**Revised Last Trading Day for  
Onshore Chinese Renminbi/U.S. Dollar (“RMB/USD”) Futures**

The Chicago Mercantile Exchange Inc. ("CME" or "Exchange") is amending the last trading day for the Exchange's extant Onshore Chinese Renminbi/U.S. Dollar ("RMB/USD") futures contract.

Specifically, CME is changing the last trading day for RMB/USD futures from the first Beijing business day to the second Beijing business day immediately preceding the third Wednesday of the contract month.

This change will become effective on trade date **Monday, March 25, 2013** starting with the July 2014 futures expiry. For the April 2013 through June 2014 futures expiries, the last trading day for RMB/USD futures will remain unchanged as the first Beijing business day immediately preceding the third Wednesday of the contract month.

Attachment 1 provides a revised listing of the last trading dates for the individual futures expiries in RMB/USD futures that will be listed for trading effective Monday, March 25.

These contracts are listed by and subject to the rules of CME.
