SUBJECT: **UPDATE: Expanded Contract Month Listings for CME E-Livestock Futures  
Beginning Monday, January 3, 2005**

Effective Monday, January 3, 2005, CME will increase the number of contract months available for trading in the CME E-Livestock products (electronic versions of CME Live Cattle, CME Lean Hogs and CME Feeder Cattle).

With these additions, the following number of contract months will be available for trading on CME Globex® at all times:

- CME Live Cattle: 6 contract months (in the February cycle, **and 2 contract months in the serial (January) cycle**)
- CME Lean Hogs: 7 contract months
- CME Feeder Cattle: 6 contract months

Beginning on Monday, January 3, 2005, the following contract months will be available for trading on CME Globex:
