CME Trading Floor

Commodity Futures, Foreign Exchange, Interest Rate, and GSCI products will close at 12:00 noon. Commodity Options will close at 12:02 p.m. Equity Index products will have normal trading hours.

GLOBEX

Foreign Exchange and Interest Rate products traded on GLOBEX during RTH will close at 3:15 p.m. (same as Equity Indexes). Commodities, GSCI, Fertilizer and Weather products traded on GLOBEX during RTH will close at 12:00 noon.

CBOT Trading Floor

Financial Products will close at 12:00 noon. Agricultural and Stock Index products will have normal trading hours.

Dow-AIG products will close at 12:00 p.m. Financial and Metal products will close at 12:30 p.m. Agricultural and Stock Index products will have normal trading hours.

SPAN files will be produced on Friday, July 1, 2005 according to the normal schedule. There will be no SPAN files produced on Monday, July 4, 2005.

On Friday, July 1, 2005, the out-trade reconciliation print times and final reconciliation deadlines will adhere to their normal schedules.
