ACTION: QLogic Corporation (QLGC) has announced a 2 for 1 stock split. **The ex-distribution date is March 3, 2006.** Opening positions and start of day prices for March 3 will be based on final position and settlement prices from Thursday, March 2, 2006. This corporate action will be coordinated with the Options Clearing Corporation.

CME FUTURES SYMBOL: QL remains the same

NUMBER OF CONTRACTS: Doubled

EFFECTIVE DATE: Effective the opening of business March 3, 2006 and thereafter.

MULTIPLIER: 100 multiplier remains the same

DELIVERABLE PER CONTRACT: 100 QLogic Corporation (QLGC) Common Shares remain the same

APPLICABLE CONTRACT MONTHS: March, April, June and September

SETTLEMENT PRICES AND POSITIONS: Positions held at the close of trading on Thursday, March 2, 2006 will be doubled before the beginning of trading on Friday, March 3, 2006.

All previous day's settlement prices shall be adjusted by dividing by 2 and rounding normally to the nearest penny. Positions will be marked to the adjusted settle price.
