**DESCRIPTION:** The Rogers International Commodity TRAKRS Index is a total return index that will equal the product of the Rogers International Commodity Index (the "RICI") and the Multiplier, plus the Amortizing Spread.

**CONTRACT SIZE:** The contract is valued at \$1 times the Rogers International Commodity TRAKRS Index.

**TRADING VENUE:** CME® Globex®

**TRADING HOURS:** Mondays through Fridays from 8:30 a.m. to 3:00 p.m. Central Time.
