ACTION: Starbucks Corporation (SBUX) has announced a 2 for 1 stock split. **The ex-distribution date is October 24, 2005.** Opening positions and start of day prices for October 24 will be based on final position and settlement prices from Friday, October 21, 2005. This corporate action will be coordinated with the Options Clearing Corporation.

CATEGORY: 2 for 1 Stock Split

EQUITY SYMBOL: SBUX (Starbucks Corporation)

ONECHICAGO SYMBOL: SBUX1C remains the same

CME FUTURES SYMBOL: SR remains the same

NUMBER OF CONTRACTS: Doubled

EFFECTIVE DATE: Effective the opening of business October 24, 2005 and thereafter.

MULTIPLIER: 100 multiplier remains the same

DELIVERABLE PER CONTRACT: 100 Starbucks Corporation ("SBUX") Common Shares remain the same

APPLICABLE CONTRACT MONTHS: October, November, December and March 2006

SETTLEMENT PRICES AND POSITIONS: Positions held at the close of trading on Friday, October 21, 2005 will be doubled before the beginning of trading on Monday, October 24, 2005.

All previous day's settlement prices shall be adjusted by dividing by 2 and rounding normally to the nearest penny. Positions will be marked to the adjusted settle price.
