FINAL SETTLEMENT PRICE:

Final settlement price will be provided by Mkt Ops and shall be the cumulative average of the Daily GC Ethanol Basis Swap settlement prices during the last calendar month that a contract is available for clearing. For example, the final settlement price for a November GC Ethanol Basis Swap would be the cumulative average of all Daily Settlement prices of the GC Ethanol Basis Swap during the month of October. Final settlement will be at approximately 9:00 AM Chicago time on the first business day after the Last day of Clearing (in the above example this would be the first business day in November). FTS will send final price over market data ticker and ASG will insert price into end of day price on the first business day after the Last day of Clearing.
