MOSA Processing

MOSA will only run an "AM" cycle on Monday, January 21st. CME MOSA transactions cleared on Monday will be posted for **Tuesday's** clearing cycle.

The deadline to submit trades to the AM inter-exchange processing cycle on Monday will be its normal time of 7:00 am CST.

EROSION Processing

CME clearing will not process NYMEX Erosion on Monday, January 21st

Since Martin Luther King, Jr. Day is not defined as a NERC holiday, CME Clearing will process double erosion for all firms with positions in the NYMEX PJM contracts on **Tuesday**, **January 22**nd.

CME Clearing will calculate final erosion for **both Monday**, **January 21**st **and Tuesday**, **January 22**nd **on Tuesday** for settlement on **Wednesday**, **January 23**rd.

Customer Gross Margin File Submission

CME Clearing will use the CGM file submitted on Friday, January 18th for processing on Monday, January 21st even if a firm submits a new CGM file for processing on Monday.

Processing of Performance Bond Collateral

There will be no posting of collateral transactions dated Monday, January 21st, 2019 and clearing firms will be unable to deposit or withdraw collateral on Monday, January 21st.

Money Market Mutual Funds will be closed for all transactions on Monday, **January 21**st. No purchases or redemptions will be allowed for the IEF-2 program on Monday, January 21st. **Please refer to IEF2 processing deadlines schedule for January 21**st on the last page of this advisory.

A.M. Settlement Confirmations

Settlement variation and performance bond cash call amounts resulting from Friday, January 18th and Monday, January 21st, RTH settlement cycles will be confirmed by the settlement banks by 7:30 a.m. on Tuesday, January 22nd. Settlement banks will process cash flows resulting from Friday and Monday's RTH settlement cycle on Tuesday, January 22nd.

As securities near their maturity date, the values of these assets change. With this, Clearing Members may see changes in the asset values on deposit with CME the morning after the holiday. Changes in the value of collateral from Friday to Monday may result in PB calls, which will be banked on Tuesday morning.

Futures Foreign Currency Performance Bond Cash Withdrawals

Due to the holiday's effects on transaction processing, please note the following value dates on foreign currency performance bond cash withdrawals for entries made prior to 9am. Entries made after 9am will add an additional day for settlement. Cutoff times may vary by currency.
