Please be advised that CME Clearing will be observing the Memorial Day holiday on Monday, May 26, 2025.

Since May 26<sup>th</sup>, 2025 is a USD holiday (Memorial Day) and GBP holiday (Spring Bank Holiday), GBP & USD swaps submitted on Monday, May 26<sup>th</sup>, 2025 will clear on Tuesday, May 27<sup>th</sup>, 2025 and will settle on Wednesday, May 28<sup>th</sup>, 2025. All non-deliverable swaps submitted on Monday, May 26<sup>th</sup>, 2025 will clear on Tuesday, May 27<sup>th</sup>, 2025 as these currencies are non-deliverable and settle in USD. For all other currencies it will be business as usual.
