## Testing Overview

---

The objectives of the mock trading session are to ensure customers can access the following futures and options products:

The mock trading session dates will be on Saturday in order to test in production:

- COMEX through Front End Clearing (FEC), NYMEX/DME through TMS
  - ~~Saturday July 25, 2009 (Trade date 7/27) COMEX, NYMEX, DME- Completed~~
  - Saturday August 1, 2009 (Trade date 8/3) COMEX, NYMEX, DME
  - Saturday August 8, 2009 (Trade date 8/10) COMEX, NYMEX, DME
- COMEX and NYMEX/DME through FEC
  - Saturday August 22, 2009 (Trade date 8/24) COMEX, NYMEX, DME
  - Saturday August 29, 2009 (Trade date 8/31) COMEX, NYMEX, DME

Trade types within the asset classes will be:

- Pit Trades – Client Application Training, or clearing staff enters trades.
- Globex – Inject trades, support from GCC if needed.
- ClearPort Trades – Facilitation desk trade entry and trade injection from prior day.

- Ex-Pit – Inject trades, Client Application Training, or clearing staff enters trades

#### FEC Functionality:

- Giveups
- APS
- SLEDS
- The Cleared Trades API will be available. COMEX and NYMEX confirms will be delivered to firms in the New Release environment on Monday. In addition, NYMEX and DME confirms will be available in Sat. in Production, through normal NYMEX testing procedures.

#### Test Performance and Capacity:

- During the Mock Trading Session, we may run a short performance and capacity test. If needed, we will select a set of production trades from the Friday prior to the Mock Session which simulate production. We will replay these trades from 9:30 to 10:00 AM. We will announce the beginning of this performance and capacity testing on the customer conference bridge before the replay of trades begins – see test timeline for details.

#### Participation is expected from the following service providers:

- WhenTech: Replay prior day's production trades. Orders will be sent directly to clearing: COMEX trades will post FEC, NYMEX trades will print on the floor.
- ISVs: TT and CQG will support the Mock Trading Sessions
- Back office service providers: SunGard and ION Trading will begin supporting the Mock Trading Sessions on 8/8, 8/22, and 8/29.

## Test Outputs

---

### Saturday

- NYMEX/DME Intraday and Final Member Trade Files will be available via email, if requested. Please contact [Anthony.DiBenedetto@cmegroup.com](mailto:Anthony.DiBenedetto@cmegroup.com) to request these files. The request must be received by Friday, prior to the Mock Trading Session.

### Monday following the Saturday Mock Session

- Clearing confirms will be routed to firms' New Release queues on Monday, following the mock session.
- Reports and files will be routed to New Release on Tuesday morning following the clearing cycle on Monday night.

## Out of Scope

---

- Will not run the deliveries system during the mock session.
- Confirms will not be sent to firms through Production queues and channels.
  - (As noted above, Firms **will** be able to receive confirms through their New Release (NR) queues on Monday, following the Mock Trading Session.)

## Customer Test Timeline

---

The Customer Test will be an opportunity for customers to participate in a mock trading session with CME Group, COMEX, NYMEX, and DME in advance of the COMEX launch on August 16 for the August 17 trade date. The NYMEX and DME launch will be September 13 for the September 14 trade date.

There will be a general conference bridge line open during the testing. Customers are encouraged to dial into this line to listen to any information related to the mock trading session.
