ACTION: The Options Clearing Corporation (“OCC”) has been advised that ProShares Ultra Real Estate (URE) has announced a 1-for-5 reverse stock split. As a result of the reverse stock split, each URE Share will be converted into the right to receive 20 (New) ProShares Ultra Real Estate Shares. The reverse stock split will become effective prior to the open of business on April 15, 2010.

CATEGORY: 1 for 5 Reverse Split

EQUITY SYMBOL: ProShares Ultra Real Estate (URE)

ONECHICAGO SYMBOL: URE1C changes to URE2C

CME FUTURES SYMBOL: **URE** remains the same

NUMBER OF CONTRACTS: No change

EFFECTIVE DATE: **Thursday, April 15th, 2010**

MULTIPLIER: 100 (e.g., 1.00 equals \$100.00) remains the same

APPLICABLE CONTRACT MONTHS: Apr 2010, May 2010, June2010, Sep 2010

SETTLEMENT PRICES AND POSITIONS: All previous day’s settlement prices shall be adjusted by dividing by 2 and rounding to four decimal places.
