ACTION: The Options Clearing Corporation ("OCC") has been advised that ProShares UltraShort FTSE/Xinhua China 25 (FXP) has announced a 1-for-5 reverse stock split. As a result of the reverse stock split, each FXP Share will be converted into the right to receive .20 (New) ProShares UltraShort FTSE/Xinhua China 25 Shares. The reverse stock split will become effective prior to the open of business on April 15, 2010.

EQUITY SYMBOL: ProShares UltraShort FTSE/Xinhua China 25 (FXP)

SETTLEMENT PRICES AND POSITIONS: All previous day's settlement prices shall be adjusted by dividing by 2 and rounding to four decimal places.
