We are pleased to announce that NYMEX and DME energy products will be added to the product suite supported by our Deliveries Plus application beginning Monday, November 1<sup>st</sup>. The energy complex will be joining CBOT Grains, CBOT Financials, CME FX, COMEX & NYMEX Metals in Deliveries Plus.

### **Energy Product Suite Transition to Deliveries Plus**

The transition of the energy product suite to Deliveries Plus will occur after close of business on Friday, October 29<sup>th</sup>. All energy deliveries currently in progress will be migrated in their current state into Deliveries Plus. Beginning on Monday, November 1<sup>st</sup>, firms will be responsible for handling all November contracts in Deliveries Plus. Any deliveries that are not payment complete by 11/1 for the October contracts can be handled via Fax or through Deliveries Plus.

Customer information will be migrated automatically to Deliveries Plus for all products.

SPECIAL NOTE: On November 1<sup>st</sup>, firms should enter intents for the Heating Oil, RBOB Gasoline, Oman Crude Oil, Polypropylene and Polyethylene contracts in Deliveries Plus.

  - Delivery Scheduling
  - o Reports
- Faxes will no longer be required for the allocation and processing of energy deliveries.
- Emails will be generated for every stage in the delivery scheduling process.
- Firms will be able to maintain their customers within the application
- Firms will be able to maintain their delivery contact information within the application
- Firms will be able to view the energy site information
- Reports will be made available through Document Direct & EREP on the CME Portal
- Firms will be able to view their positions real time in Deliveries Plus
- Firms will be able to view assignment details in Deliveries Plus
