SUBJECT: CBOT Position Migration

DATE: November 4, 2010

Please be reminded the migration of CBOT positions to the new Positions System will be this weekend, **Saturday, November 6, 2010**.

Please take the time before **Monday**, **November 8**, **2010** to log into the new Positions System which is available through the Portal to check that your user ID has access to "CBT" in the Exchange drop down. If you do not have a "CBT" selection in the drop down please contact Firm Support at 312-930-3444 or firmsupport@cmegroup.com to request access.

On **Saturday**, **November 6**, **2010** Clearing will move all open interest from the old Positions System positions to the new Positions system. Firms will have the option to view their converted positions on Saturday morning between 9:00 AM 12:00 Noon Chicago time.

In order to view the positions log into the new Positions System and select "ITD 11/08/2010" from the Cycle drop down in the user interface. Users will be able to perform Excel downloads of data to confirm all open positions.

On **Monday, November 8, 2010** all position adjustments, option instructions and manual PCS changes will be submitted to the new Positions System for CBOT contracts. All CBOT data will be contained in the "POS" series of reports. The existing CPM series of reports will only have data for the CME exchange.
