MOSA Processing

MOSA will only run an "AM" cycle on Wednesday December, 25^h. CME MOSA transactions cleared on Wednesday will be posted for **Thursday's** clearing cycle.

The deadline to submit trades to the AM inter-exchange processing cycle on Thursday will be its normal time of 7:00 am CST.

EROSION Processing

CME clearing will not process NYMEX Erosion on Wednesday, December 25, 2013.

CME Clearing will calculate final erosion for Wed, Dec 25th for settlement on Thursday December 26th.

Customer Gross Margin File Submission

CME Clearing will use the CGM file submitted on Tuesday December 24th for processing on Wednesday December 25th even if a firm submits a new CGM file for processing on Thursday due to the Christmas Holiday.

Processing of Performance Bond Collateral

The U.S. bank holiday will prohibit the posting of collateral transactions dated Wednesday, December 25, 2013. Consequently, clearing firms will be unable to deposit or withdraw collateral on Wednesday, December 25nd. Clearing 21 will not be available for Asset Management Banking transactions on Wednesday, December 25, 2013.

The "Interest-Earning Facility" (IEF) will be closed for all transactions on **Wednesday**, **December 25th**. No purchases or redemptions will be allowed for the IEF-2, IEF-3, IEF-4 or IEF-5 programs on **Wednesday**, **December 25th**. **Please refer to IEF2 processing deadline schedules for December 24th and 26th on the last page of this advisory.**

A.M. Settlement Confirmations

Settlement variation and performance bond cash call/release amounts resulting from Tuesday, December 24th and Wednesday, December 25th, RTH settlement cycles will be confirmed by the settlement banks by 7:30 a.m. on Thursday, December 26th. Settlement banks will process cash flows resulting from Tuesday and Wednesday's RTH settlement cycle on Thursday, December 26th. OTC FX settlements from the RTH cycle from Tuesday, December, 24th will be confirmed by the settlement banks by 7:30 a.m. on Thursday, December 26th (no bank confirmation on the 25th).

As securities near their maturity date, the values of these assets change, this can result in a change to their Performance Bond values at CME. With this, you may see changes in the asset values on deposit with CME on Thursday, morning after the holiday. Increase/decrease in the values of these collateral assets from Tuesday and Wednesday may result in PB call/release, which would be banked on Thursday, morning. These PB calls/releases would be banked in addition to the regular RTH settlements for Tuesday and Wednesday.

SVIEF for December 24th and December 25th RTH settlements will be for value date December 26th
