SUBJECT: **BPS™ IRS Form 1099 Notification #2**

November 30, 2015 marks the end of the 2015 BPS tax year for brokerage. The following 1099 processing schedule will be effective for the 2015 tax year:

DATE:	ACTION:
Monday, December 07, 2015	Deadline for initial 1099 adjustments.
Tuesday, December 08, 2015	Preliminary 1099 Reports for CME, CBT, NYMEX and COMEX will be available in EREP (Enterprise Reporting Portal) as report named "Prelim Broker's Yearly Banking Summary" which will reflect initial adjustments made by December 7, 2015.
Thursday, December 31, 2015	Deadline for final <u>adjustments</u> to the Firm 1099 Reports.
Saturday, January 02, 2016	Final 1099 Reports for CME, CBT, NYMEX and COMEX will be available on EREP as "Final Broker's Yearly Banking Summary".
Tuesday, January 05, 2016	Deadline for reporting <u>any</u> discrepancies in 1099 Reports to the CME Clearing House.
Friday, January 15, 2016	Distribution of 1099 Statements to clearing member firms. As in past years, firms will be able to elect the CME Group Document Processing Center to send out the statements for a fee. Details will be included on a subsequent advisory.
Friday, January 29, 2016	Deadline for clearing member firms to distribute 1099 statements to brokers.
March 2016	Deadline for CME sending 1099 Statement Tape to the IRS.
