SUBJECT: Delisting Nine (9) Gasoil and Low Sulphur Gasoil Related Futures and

Options Contracts

The New York Mercantile Exchange, Inc. (NYMEX or Exchange) delisted a series of Gasoil and Low Sulphur Gasoil related futures and options contracts on Monday, January 5, 2015 as set forth in the table below. The delisting of these contracts is a result of the Exchange's prior announcement that the last listed contract month for these contracts shall be December 2014.

As a result of the delisting, information regarding these contracts have been deleted from the respective product rule chapters, related position limits in the Position Limit, Position Accountability and Reportable Level Table located in the Interpretations and Special Notices Section of Chapter 5 (Trading Qualifications and Practices) of the NYMEX Rulebook, and the CME Globex non-reviewable ranges located in Rule 588.H of the NYMEX Rulebook.

Via NYMEX Submission No. 14-423 dated November 10, 2014, the Exchange previously notified the Commodity Futures Trading Commission (CFTC) of the delisting of previously listed contract months of the following contracts: Low Sulphur Gasoil Average Price Options (commodity code LSO), Low Sulphur Gasoil (100mt) Calendar Month Futures (commodity code LSM), Low Sulphur Gasoil (100mt) Penultimate Day Futures (commodity code LSP), Singapore Gasoil (Platts) vs. Low Sulphur Gasoil Futures (commodity code LSS), and ULSD 10ppm Cargoes CIF Med (Platts) vs. Low Sulphur Gasoil Futures (commodity code LSL).

Via NYMEX Submission No. 14-471 dated December 8, 2014, the Exchange previously notified the CFTC of the delisting of previously listed contract months of the NY Harbor ULSD vs. Gasoil Futures (commodity code HA).

Finally, via NYMEX Submission No. 14-484 dated December 17, 2014, the Exchange notified the CFTC of the delisting of previously listed contract months of the following contracts: ULSD 10ppm Cargoes CIF NWE (Platts) vs. Low Sulphur Gasoil Futures (commodity code LSU) and European Diesel 10ppm Barges FOB Rdam (Platts) vs. Low Sulphur Gasoil Futures (commodity code LSE) and the Low Sulphur Gasoil Crack Spread Financial Future (commodity code LSC).

The CFTC will be notified of the delisting of these products during the week of January 12, 2015, via the weekly notification procedures set forth in Part 40 of the CFTC Regulations.
