# Renewable Fuels

The scramble to transition from fossil fuels to more sustainable fuels, such as renewable diesel or hydrotreated vegetable oil, is drawing energy traders to the agricultural markets.

The growing demand for renewable fuels has increased interest in soybean oil. US production of renewable diesel, a drop-in sustainable fuel alternative to diesel, is expected to reach around 14 million tons per year by 2030, a three-fold increase from current 2021 levels.

Other products, such as the waste oils and additional secondgeneration feedstocks, are expected to feature in the global bio markets, but greater supplies will be needed in the coming years to meet the growing demand from the sector.

In the years ahead, the supply of additional products (like sustainable aviation fuel) is expected to increase as the industry looks to further decarbonize its fuel choices. Soybean oil and other feedstocks are expected to feature in this growing market in the run up to net zero in 2050 (and beyond).


